Ribbons will be awarded 1st—4th place in each jump height class to dogs with qualifying scores. Green Ribbons will be awarded to all dogs with qualifying scores. Master level dogs earning a Double, Triple, Quadruple Quintuple or Sextuple Q will be awarded a corresponding pin. Rosettes will be awarded to dogs completing a title. Special rosette awarded to any dog earning the MACH or PACH title. Each dog entered will receive a gift at check in. One toy per dog per weekend.

Proceeds from the match will be donated to worthy canine causes including, but not necessarily limited, to the Terri Lockett Memorial Spay/Neuter Fund administrated by Humboldt Dog Obedience Group.

Classes offered: Standard and FAST. One course will be set in each ring. You may run the numbered course or your own pattern. No scoring or prizes will be offered. Walk through will begin as soon as the course is set, approximately 1:00 pm. Entry fees will not be refunded if the dog is absent, disqualified, excused, or barred from competition by action of the trial committee. If, because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or complete the match, no refund of entry fees will be made.

Dogs must be a minimum of 1 year in age. Any AKC eligible dog may enter. Dogs do not need to be entered in the regular trials. Dogs may be entered multiple times in the same class with a maximum of 4 runs per dog. Event is limited to 400 runs. Each run will be a maximum of 60 seconds.

Toys and clickers are allowed in the ring. Food is not allowed in the ring. Maximum course time will be strictly enforced. No harsh verbal or physical corrections allowed. Excusal for dog fouling the ring.

Saturday, Sunday and Monday at 8:30 am

Course Familiarization / Warm-ups

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of a class. The walk through is restricted to handlers entered in the class. A warm-up jump will be provided for each ring.

Move-Up Regulations

Dogs may be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that the request is received in writing by the Trial Secretary, no later than 6 pm on the Monday preceding the event. Day to day move ups are allowed providing the Trial Secretary is notified at the show site, in writing within 15 minutes of the last dog completing the course.

Notice to Exhibitors

- The trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds. Mixed breed dogs that have been listed with AKC Canine Partners may participate provided their listing number has been recorded on the entry form.
- Running order will be determined by random draw. Handlers with more than one dog in a class will have those dogs separated as much as possible.
- If a dog and/or handler are dismissed, regardless of the reason, there will be NO refund of entry fees.
- After closing date bitches in season will receive refund of amount paid less \$10 per day processing fee.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee.
- Withdrawal of entry before closing date will receive refund less \$7 processing fee.
- Refunds are mailed in the time frame of seven days before to seven days after the event.
- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- EXHIBITORS ARE RESPONSIBLE FOR COMPLETE, ACCURATE, AND LEGIBLE INFORMATION ON THEIR ENTRY FORMS; ILLEGIBLE OR INCOMPLETE ENTRIES CANNOT BE ENTERED IN THE TRIAL.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and /or children. Any exhibitor whose dogs and /or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.
- All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.
- Exhibitors are responsible for being at the ring gate when it is their turn to run.
- Please be courteous and pick up after your dog.
- Dogs under four months of age are prohibited at AKC Agility Trials
- Do not leave animals unattended in vehicles. The club will not be responsible for damage to vehicles resulting from the rescue of overheated animals.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations. Rabies vaccine is required in the State of California.
- Failure to follow the instructions of the Show Committee or their Agent will result in a Bench Committee Hearing.

The rings will be outdoors on grass and measure 100' x 100'. Rings will be located in on the soccer field. Bring shade.
